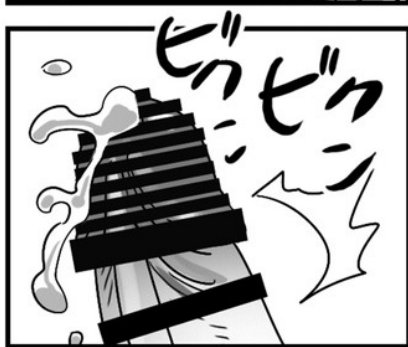
The fourth video came to me as well, as if it were to be expected...

This is the video showing all the characters Mother (A) fought in the flashbacks. Like I said in Vol. 001, the original story was supposed to take place in 1990's Japan, but in scenes like the flashback, the Mother (A) and the Daughter (B) appear to be of similar age, so in order not to cause anything to feel out of place, I used hairstyles from the 1960's~1970's as reference and had isaki-sama, who oversees the drawings, design them for me. I had the opponents in Vol. 001 star in old-fashioned hair for that same reason.

Upon researching the hairstyles of the time, aside from the hairstylists' creativity, I was very intrigued by the fact that the people who devoted their time to the entertainment/comedy or sports fields tended to be the ones who achieved worldwide recognition through the media. This is a side note, but there's something called a "Center versus Periphery Theory" among the hypotheses surrounding dialect distribution, but if you apply that to hairstyles and assume that these hairstyles spread in a concentric circle across the whole nation with Tokyo (Kinki) at the origin, then the hairstyle of the townspeople residing in Satsuma or Mutsu could be considered as something you could learn from a history class. Imagining that made the process very enjoyable.

Due to various reasons, the characters that appear in the Hei Circle's works are nameless except for a select few, but for convenience, we assign them names like "A" or "B" during the production stage. Also, the rival character from Vol. 001 is "C", and the rival character from Vol. 002 is "D"... And, the reason why this rival character was named "F" is that I3- completely skipped over "E" during the creation stage (sweat).

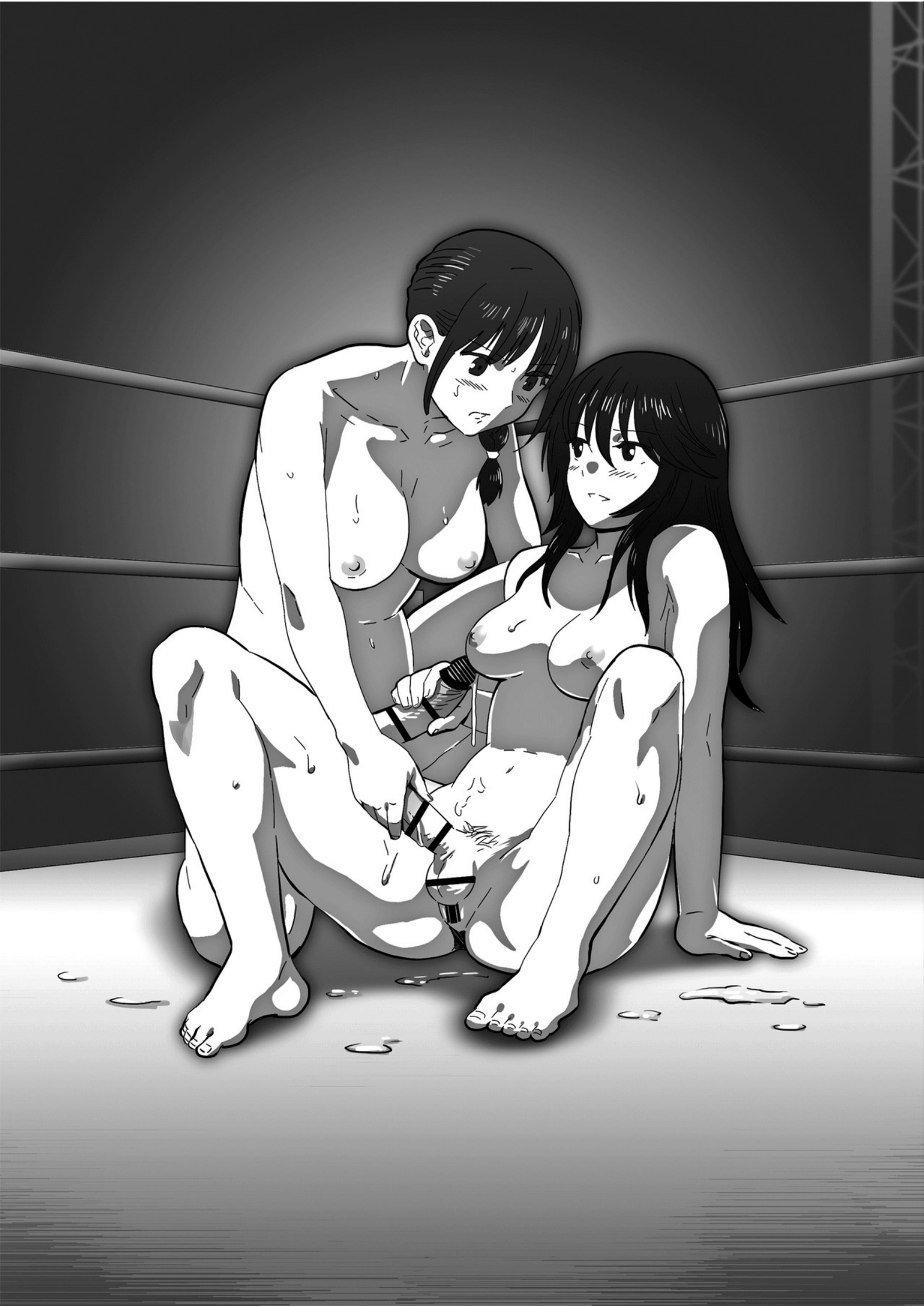
